### **Instructions**

To nominate a professional for the Luminary Star award, provide the required information in the form below in a Word or PDF doc and email your nomination along with optional letters of recommendation to our chapter administrator Victoria Stanton, [chapteradmin@prsa.org](mailto:chapteradmin@prsa.org).

### **Eligibility**

- Nominees should have more than 15 years of experience excluding internships or part-time employment.
- Nominees must be current members of PRSA Georgia and have been members for at least five years.

### **Nominator**

- Nominations may be submitted by any PRSA Georgia member.

### **Judging Criteria**

- A panel of judges will evaluate the nominees using this criteria:
  - Service to the Chapter (50%)
  - Professional accomplishments (40%)
  - Professional traits and qualities (10%)

### **1. Contributions to the Chapter**

## **3. Professional Traits and Qualities**

Discuss why you think the nominee is an excellent candidate for this award. Include relevant information in addition to what is shown above, with emphasis on how the nominee shows high ethical standards, team participation and leadership, and work excellence, creativity, and quality. (Maximum 200 words)

## **4. Optional Letters of Recommendation**

Letters from other PRSA Georgia members discussing why the nominee is an excellent candidate for this award may be attached as PDF documents below. **Any letter of recommendation should provide additional information not included in this nomination form.** Letters of recommendation are not required.
